

MAJORITY RELEASE AGREEMENT

WHEREAS, I _____, being over eighteen years of age, in consideration of One and 00/100th (\$1.00) Dollar and other good and valuable consideration, the receipt of which is hereby acknowledged, have requested of Richmor Aviation, Inc., whose principle office is located at Columbia County Airport, Hudson, NY, permission to enroll in a course of flight instruction and provide a flight training program, and any other related form of flight related activity incidental to the course of flight instruction,

AND WHEREAS, I have been explicitly advised of the potential risks and hazards involved in a course of flight instruction and general aviation flying in particular, and whereas I have been fully and completely advised prior to executing this agreement that a course of flight instruction and a flight training program, and any other related form of flight related activity incidental to the course of flight instruction, general aviation flying, involves a high degree of risk and the possibility of property damage and serious personal injury and hazards to me and others, including but not limited to the possibility of death, which is inherent in the Aviation Industry inclusive of flight training, flight related activity, or flying in general, and having been fully informed of these hazards and risks, including the possibility of death, and fully and completely comprehending and understanding same, I still desire permission to commence a course of flight instruction and have Richmor Aviation, Inc., provide me with a flight training program, and any other related form of flight related activity incidental to the course of flight instruction necessary for a flight training program, or engage in general aviation flying using Richmor Aviation, Inc., facilities aircraft and equipment.

AND WHEREAS, it is the purpose of this Agreement to release, Richmor Aviation, Inc., its directors, officers, shareholders, employees, agents, representatives, successors and assigns, any owner or owners of aircraft leased or operated by or on behalf of Richmor Aviation, Inc. from any and all liability for all personal injuries and property damage that may occur during the course of flight instruction, or any other flight related activity, and to assume the risks of the above related flight activities.

NOW THEREFORE, the undersigned, in order to induce Richmor Aviation Inc. to provide flight training I hereby: (1) assume all the risks and hazards attendant with any flight training, flight related activity, or flying in general (2) forever release Richmor Aviation, Inc., it's directors, officers, shareholders, employees, agents, representatives, successors and assigns, and any owner or owners of aircraft leased or operated by or on behalf of Richmor Aviation, Inc. from and against any and all causes of actions, claims, rights or demands which I or my heirs, or relatives, executors, administrators and assigns can or might have as a result of any loss, damages, expenses and personal injury, death, or property damage which I or any person may suffer or sustain, in law or in equity and (3) agree to indemnify and hold harmless Richmor Aviation, Inc. its directors, officers, shareholders, employees, agents representatives, successors or assigns, and any owner or owners of aircraft leased or operated by or on behalf of Richmor Aviation, Inc. from and against any and all claims, damages, losses and expenses, suits, and judgments, including but not limited to those attorney fees and disbursements, however caused, including but not limited to those for property damage, bodily injury including death, arising out of or in connection with any and all flight training, flying in general, use and/or maintenance of any aircraft, flight related activities, any airport conditions and/or the performance, nonperformance, breach or alleged breach of any representations or obligations of Richmor Aviation, Inc., it's directors, officers, shareholders, employees, agents, representatives, successors and assigns, or any owner or owners of aircraft leased or operated by or on behalf of Richmor Aviation, Inc. provided that such claim, damage, loss or expense is attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property, including loss of use there from, regardless of whether or not caused in part by a party indemnified hereunder. Such obligation shall not be construed to negate, abridge, or otherwise reduce any other right or obligation of indemnity that would otherwise exist as to any party or person described in this paragraph.
